PREAMBLE:

In accordance with provisions of the KERC (Fuel Cost Adjustment Charges) Regulations, 2013, dated 22nd March 2013 and KERC (Fuel Cost Adjustment Charges) (First Amendment) Regulations, 2013, dated 4th December 2013, the ESCOMs have filed their applications on the following dates for approval of Fuel Cost Adjustment

charges for the billing quarter January – March, 2015 based on the Fuel Cost incurred during July-September, 2014.

1. The FAC claimed by the ESCOMs are as follows:

- 2. The Commission has computed the allowable FAC for the 2nd Quarter of FY15 on the basis of the following:
 - i. The source wise / ESCOM wise energy as per SLDC reconciliation statement dated 25th November, 2014 among ESCOMs.
 - ii. The allowable variable charges in respect of KPCL thermal stations have been determined based on the applicable formula as per the approved power purchase agreement between ESCOMs and KPCL.
 - iii. Z Factor of BESCOM and MESCOM has not been considered as the same pertains to FY14 and could be factored in the APR for FY14.
 - iv. Retail Sales for the second quarter of FY15 are computed as per Clause5.1 of the KERC (Fuel Cost Adjustment Charges (First Amendment)Regulations, 2013.

3. The FAC as computed by the Commission are as follows:

The Commission notes that while there is a decrease of 11.45 paise per unit of sale in the variable cost of thermal stations, the actual overall power purchase cost per unit is more than the approved power purchase cost per unit for the 2nd quarter of FY15. The increase in overall per unit cost of power purchase for the period July-September, 2014 as furnished by the ESCOMs as per format III is as follows:

Therefore, the Commission orders as follows:

Commission's Order:

- i) In accordance with the provisions of the KERC (Fuel Cost Adjustment Charges) Regulations 2013 as amended on 04.12.2013, the Commission, having recognized the decrease in fuel cost adjustment charges for all the ESCOMs except MESCOM in the second quarter of FY15 and the overall increase in power purchase cost, decides to allow all the ESCOMs except MESCOM to adjust the savings in FAC against the overall increase in power purchase cost.
- ii) In case of MESCOM, the Commission decides to allow collection of FAC to an extent of 1 paise /unit during the billing quarter January March 2015.
- iii) Hence, there is no FAC to be collected from consumers of all ESCOMs except MESCOM separately during January March, 2015.
