1. This is an appeal under clause 21.02 of KERC (CGRF & Ombudsman) Regulations, 2004 against the orders passed by CGRF, BESCOM, Bangalore Urban District, Bangalore dated 31.08.2016.

2. The case was posted for hearing on 07.10.2016. Sri M.A.Delvi, authorised representative for the appellant was present. The AEE was also present. The learned Advocate for the appellant and the AEE made their submissions. In this case the Appellant had asked for a third party inspection of the meter. Accordingly, it was arranged and the report was submitted to Electrical Inspectorate. However, the Electrical Inspectorate after seeing the report have observed that the third party has not properly recorded the technical flaws. Hence, the Appellant is asking for a third party inspection again.

3. The appeal is allowed with a direction to the AEE to consider the case afresh keeping in mind the observations made by the Electrical Inspectorate and pass suitable orders as per law at the earliest.
