Shri N.Jagadeesh, Karnataka Rice and Flour Mill, Market Road, Soraba, Shimoga District has filed this representation in Form B before the Electricity Ombudsman on 27.01.2011. The matter was heard and when orders were about to be issued, it is found that Form B is not directed against the orders of the Consumer Grievance Redressal Forum (in short CGRF), but against the orders passed by the Superintending Engineer, Appellate Authority, CESC, City Works Circle, Mysore. As per KERC (Consumer

Grievance Redressal Forum and Ombudsman) Regulations, 2004, Electricity Ombudsman gets jurisdiction against orders passed by the CGRF. In the present case, no such order is found to have been issued by the CGRF. The Appellant has filed this representation against order No. CEA(«)G - 1/2004/1122 dated 31.12.2010 passed by the Superintending Engineer, Appellate Authority, Chamundeshwari Electricity Supply Corporation, Mysore, against which Electricity Ombudsman has no jurisdiction.

### **ORDER**

For the foregoing reason, the representation filed by Shri Jagadeesh is **dismissed for want of jurisdiction**. Shri Jagadeesh is advised to approach appropriate forum to seek relief against the order passed by the Superintending Engineer, Appellate Authority, Chamundeshwari Electricity Supply Corporation, Mysore.
