ORDER

1. Case called for hearing on 4.8.2020. Sri Ajay. J. Nandalike, Advocate for petitioner appeared through video conferencing to submit his arguments
2. The petitioner sought the prayer, as follows :
 - (a) Issue direction to the respondents to roll over the energy banked by the petitioner from March 2020 to May 2020, up to May 31, 2021 or any other such appropriate period as this Hon'ble Commission deems fit in the interest of justice and equity.
 - (b) Pass such other and incidental orders, including an order as to costs, as may be deemed fit / appropriate in the facts and circumstances of the case.
3. We heard the case. During the hearing, the learned Counsel for the petitioner has filed a memo for withdrawal of the petition through email stating that the Commission by way of its general Order dated 25.6.2020 has ordered to allow carry forward the banked energy remaining unutilized as on 31.5.2020 up to 31.7.2020 in respect of mini hydel generators who have executed wheeling and banking agreement, subject to the condition that any banked energy to be allowed to carry forward and remaining unutilized till 31.7.2020, shall be deemed to have been supplied to the concerned ESCOM at no cost and accordingly Article-9 of the WBA was amended for mini hydel projects. Therefore the petitioner craves permission to withdraw the petition.
4. The memo filed by the petitioner dated 4.8.2020 is taken on record and disposed accordingly.
