Further he stated that, he had intimated his representative not to proceed with the case, even today he has no any claim with HESCOM as the matter is settled between them on 21.05.2021. The Learned Counsel for the Respondent and the Appellant Representative have also submitted that they have no any objections to accept the memo filed by the Consumer/Appellant. Under these circumstances, I find no hurdle to accept the memos dated 29.10.2021 and 27.12.2021. With this I pass the following order: -
