This complaint petition is taken up today at the instance of the Counsel for the complainant. The Counsel for the complainant and Respondent-2 (Just Law, Advocates) submitted that this complaint may be disposed of in terms of the Order passed in Complaint Nos. 12 to 24/2017. Considering the submissions, we deem it proper to dispose of the complaint petition.

As per Regulation 14 of the KERC(Terms and Conditions for Open Access) Regulations, 2004, the complainant may approach SLDC for dispute resolution. SLDC shall hear the parties and dispose of the application within a period of 4 weeks.

The Counsel for complainant submits that the complainant may be protected from disconnection of power supply. It is ordered that there shall be no disconnection of power supply to the complainant's installation, subject to compliance of section 56 of the Electricity Act, 2003.

Just Law, Advocates are permitted to file Vakalath for Respondent -2.

The complaint petition is disposed off accordingly.
