Case called. Heard the counsel for the complainant. He submits that this is a dispute relating to Open Access and that the SLDC has failed to resolve the same under regulation 14 of the KERC (Terms and Conditions for Open Access) Regulations, 2004.

Just Law, Advocates appear for R-2. Heard the counsel. He submits that bills are raised at temporary tariff as per the said Regulations.

The Counsel for complainant submits that the complainant may be protected from disconnection of power supply. It is ordered that there shall be no disconnection of power supply to the complainant's installation, subject to compliance of section 56 of the Electricity Act, 2003.

Arguments are concluded. As per Regulation 14 of the aforesaid Regulations, the complainant may approach SLDC for dispute resolution. SLDC shall hear the parties and dispose of the dispute within a period of 4 weeks.

The Complaint petition stands disposed of accordingly.
